### BOOK CLOSURE:

Pursuant to **Section 91** of the Companies Act, 2013 read with Rule 10 of the Companies Management and Administration Rules, 2014 and **Clause 16** of the Listing Agreement entered into with the Stock Exchanges, the Register of Members and the Share Transfer Books of the Company will remain closed from **17.09.2015 to 24.09.2015** (both days inclusive), to determine the Members entitled to receive the Final Dividend for the **Financial Year 2014-2015**.

### DIVIDEND:

The Final Dividend on equity shares at **Rs.1.55 (31%)** per equity share of Rs.5/- each was recommended by the Board of Directors of the Company at its Meeting held on **15.05.2015**. The Final dividend on equity shares, if declared at the Annual General Meeting, would be paid within a period of 30 days from the date of declaration, to those members whose names appear on the Register of Members as on **16.09.2015**.

### E-VOTING MATTERS

In compliance with the provisions of **Section 108** of the Companies Act, 2013 and **Rule 20** of Companies (Management & Administration) Rules, 2014 and **Clause 35B** of the Listing Agreement with Stock Exchanges, the Company is pleased to provide e-voting facility to its Members enabling them to cast their vote electronically for all the resolutions set in the Notice of AGM dated **14.08.2015**, from a place other than the venue of the meeting (e-voting). The Company has availed the e-voting services as provided by National Security Depository Limited (NSDL), the e-voting facility shall be available during the following period:

Commencement of Remote e-voting	From 9.00 A.M (IST), Sunday, 20.09.2015
End of Remote e-voting	Up to 5.00 P.M (IST), Wednesday, 23.09.2015
Cut-off date	17.09.2015.

Remote E Voting shall not be allowed beyond the end time as stated above, as the same would be disabled by NSDL thereafter.

The facility for voting through ballot paper will also be made available at the venue of the meeting and members attending the meeting who have not cast their vote through remote e-voting shall be able to cast their vote at the meeting.

A member may participate in the AGM even after exercising his right to vote through remote e-voting but shall not be allowed to vote again at the AGM.

The Company has appointed **Mr. Nagendra D Rao, Company Secretary in Practice, Bengaluru**, as Scrutinizer, for conducting the e-voting process and ballot process in a fair and transparent manner.

Once the vote on a resolution is cast by the Member, the Member shall not be allowed to change it subsequently. The voting rights of Members shall be as per the number of equity shares held by the members as on the cut-off date.

Documents pertaining to the items of business to be transacted in the AGM are open for inspection at the Registered office of the Company during the normal business hours (09:00 A.M. to 5:00 P.M.) on all working days (except Saturdays, Sundays and Public Holidays), up to the date of Annual General Meeting of the Company.

Any person, who has become a member of the Company after posting the Annual Report, may attend the meeting in person or appoint a proxy and send a requisition for a copy of the Annual Report and notice convening the Meeting.

A member entitled to attend and vote at a meeting is entitled to appoint a proxy to attend and vote on a poll instead of himself/herself and the proxy need not be a member of the Company. Proxies, in order to be effective must be received at the Registered Office of the Company not later than 48 hours before the commencement for the meeting
